### The role:

The successful candidate will have a strong background in the Motor Vehicle industry and have experience of teaching within a Further Education setting on Full time courses. The department delivers qualifications in motor vehicle repair and light vehicle maintenance from Level 1 up to Level 3 including Apprenticeships. Candidates should be qualified to at least Level 3, have an appropriate teaching qualification and possession of an assessor qualification.

The successful candidate will have experience teaching on the C&G and/or IMI L1, L2 and L3 Vehicle Maintenance and Repair programme, Units including:

- Light vehicle maintenance
- Removing and replacing light engine units and components
- Electrical units and components
- Chassis
- Driveline and transmission
- Light vehicle fault finding and rectification

#### Key Accountabilities and Responsibilities:

- 6. Substitutions for absent colleagues.
- 7. One to one learner support/tutoring other than programmes which consist entirely of formal portfolio assessment and accreditation activities.
- 8. Scheduled activities/tasks associated with the College's Quality Assurance systems.
- 9. Research and consultancy.
- 10. Maintain up to date resources.
- 11. Development of new resources and population of the VLE.
- 12. Attend relevant staff development
- 13. Management and administration. This may include:
  - contributing to College administration or the administration of education and training programmes.
  - publicity and public relations.
  - participation in appropriate team and committee meetings and course management duties including the interviewing, induction, assessment and examination of students.
  - preparing statistical returns including retention rates, examination results, student progress placement and destination.
  - participation in student monitoring and reporting and course review and evaluation procedures.
  - participation in quality assurance and control procedures.
- 14. To provide information for the self-assessment and course review process in relation to functional skills.
- 15. To liaise closely with additional support mentors to ensure a seamless approach to supporting students in vocational sessions.
- 16. To maintain records relating to the levels and achievements of students and set appropriate targets.
- 17. To maintain up to date resources.
- 18. To keep up to date with changes in specifications and advise accordingly.



19. To carry out any other duties which may be required from time to time and which are commensurate with the post.

The above duties are indicative of the requirements of the post at the time of recruitment. Staff may be asked to undertake other duties as may be reasonably required commensurate with the post, at the initial place of work or at other locations from which the College operates.

The post is offered on the Southport Education Group contract for newly appointed lecturers.
