The role:

The successful candidate will provide administrative support to the Examinations and Student Records Department across both college sites. Duties include general administration, word processing, data input and dealing with members of staff and students both in person and on the telephone.

Responsible to:

The postholder is responsible to the Examinations Officer.

Key Accountabilities and Responsibilities:

- To assess examination entry forms for accurate completion, to ensure that correct fees are charged and to issue receipts to students.
- To administer and process entries for On-Line Tests and other related duties.
- To complete examination board registrations/claims and associated forms for submission and to check examination materials upon receipt.
- To input entries and results on to Pro-Solution and to maintain an accurate database.
- To prepare examination papers and stationery in readiness for examinations and to check and despatch to the examination boards upon completion.
- To issue results and certificates to students.
- To undertake any word processing and computer input as necessary.
- To liaise with tutors, other sections and external bodies as required.
- To maintain an accurate filing system.
- To assist with enrolment duties.
- Any other duties as may be required by the Line Manager.

The above duties are indicative of the requirements of the post at the time of recruitment. It is management policy that roles and responsibilities are reviewed on a regular basis leading to possible modifications where appropriate. Staff may be asked to undertake other duties as



may be reasonably required commensurate with the post, at the initial place of work or at other locations from which the College operates.

Summary of Terms and Conditions of Employment:

There will be an annualised working year of 1498 hours. The weekly pattern of hours to be worked are commensurate with the needs of the College.

The post-holder will be entitled to receive normal remuneration for all Bank and Public Holidays normally observed in England and Wales (currently eight days) and to a further 39 working days' holiday in each holiday year (being the period from 1 September to 31 August). The College may close for a number of working days in the interest of efficiency. If this occurs the taking of annual leave will be directed by the Corporation up to a maximum of 9 days. Typically, these closures occur over the Christmas and Easter periods.

Evening and/or early morning duty may be necessary during May, June, August, September and January for enrolment/examination registration and general enquiries. Annual leave may not be taken from 20 August until the 30 September.

The postholder will be eligible to contribute automatically to the Merseyside Pension Fund (subject to qualifying conditions). Details of the scheme in operation can be found in the vacancies area of the College's website.

During their employment with the College the postholder will be expected to conduct themselves in a manner appropriate to the professional image of the College. The postholder will be expected to provide a prompt and efficient service and to maintain appropriate standards of personal appearance at all times.
